BEFORE THE 2015 JUDICIAL COUNCIL OF GUAM

RESOLUTION NO. JC15-017

RELATIVE TO ADDING TO THE LIST OF TESTING DESIGNATED POSITIONS UNDER THE JUDICIARY'S DRUG FREE WORK PLACE POLICY

- WHEREAS, the Judiciary of Guam's Drug Free Work Place Policy ("Drug Free Policy") was first adopted in 1996 in Judicial Council Resolution No. 5A-96 and later amended in 1999 in Judicial Council Resolution No. 04-99; and
- WHEREAS, pursuant to the Drug Free Policy, several positions which have direct effect on public safety or which require a high degree of trust and confidence, are "testing designated positions" and thus subject to random drug testing; and
- WHEREAS, the Judiciary has, over the years since the Drug Free Policy was adopted, created several other positions that have a direct effect on public safety and/or require a high degree of trust and confidence, and
- WHEREAS, the Judicial Council, pursuant to 7 GCA § 5102(e) and the Drug Free Policy, is authorized to adopt policy to govern personnel and make amendments to the list of testing designated positions; and
- WHEREAS, pursuant to 7 GCA §7103(c) and the Drug Free Policy, the Administrator of the Courts is responsible for administering the personnel rules and regulations of the Judiciary and its drug free workplace program; and
- WHEREAS, from time to time it may be appropriate to add other positions within the Judiciary to the list of testing designated positions.
- **NOW, THEREFORE, IT IS RESOLVED** that the Judicial Council hereby adopts the amended list of testing designated positions as attached as an Exhibit hereto, which shall replace the list of testing designated positions contained in the Judiciary's Drug Free Policy.
- **BE IT FURTHER RESOLVED** that the Administrator of the Courts is hereby vested with the authority to add to the list of testing designated positions as appropriate, provided, however, that no fewer than thirty (30) days prior to any such addition, the Administrator of the Courts shall provide notice to the Judicial Council of his or her intent to do the same.
